I am a clinical psychologist who has many years experience in the NHS and the independent sector working with individuals who have a range of mental health and personality difficulties. I also have many years experience of practicing independently carrying out assessments and providing reports for public and private family proceedings.

I qualified as a clinical psychologist in 1999, since which time I have gained post-qualification experience in high, medium, and low secure settings, along with working with individuals in the community. I have also practiced independently since this time. During the course of my career I have carried out psychological assessments and provided reports on individuals with a wide range of mental disorders, including personality disorder (along with difficulties associated with personality structure that do not amount to disorder), substance misuse difficulties, Asperger's disorder, learning difficulties, depression, Post-Traumatic Stress Disorder, in relation to a range of familial and child care difficulties and risks.

I have received training in the use of a range of assessment tools, including those based around risk, for which I have also provided training to other professionals.

I have also undergone Bond Solon training in 'Witness Familiarisation' and 'Excellence in Written Evidence'.
